### CALL TO ORDER

Mayor Casey called the meeting of the City Council to order at 7:10 P.M. in the City Council Chambers at City Hall, 65 Civic Avenue, Pittsburg, California after convening in Closed Session for the following:

Joe Sbranti led the Pledge of Allegiance.

#### **COUNCIL MEMBER REPORTS/REMARKS**

Vice Mayor Parent stated she attended the Big Little Game Luncheon sponsored by the Kiwanis Club. She attended the opening of the Recycling Center and a retirement at the Delta Diablo Sanitation District. She attended the National Women's Political Caucus and the Veterans Day Ceremony.

Council Member Johnson attended the Veterans Day Ceremony. He also attended the Mayors Conference on behalf of the Mayor.

#### **CITY MANAGER REPORTS/REMARKS**

City Manager Grisham announced the final Farmers Market this coming Saturday with music, artwork, raffles and prizes. He also commented on the Old Town Holiday Celebration coming up December 6 with music, story-telling, carolers, Christmas crafts and a tree lighting ceremony.

#### **CITIZENS REMARKS**

Theresa Miller introduced herself as the Pittsburg Red Cross liaison along with team member Patti Endo. She stated they would be returning to the Council early next year with a presentation.

Frank Wright spoke as Chair of ACORN's Pittsburg Heights Chapter. He voiced concerns about the waterfront development and plans for a port. He is requesting a forum or workshop be scheduled for the community to attend.

Marie Dryer also voiced concerns about waterfront development and potential traffic. She also asked for a workshop to be held.

The Nutrcracker group was called to speak. A 30 second ad for The Nutrcracker was shown. Vice Mayor Parent reported her fundraising efforts to bring this presentation to the CAB. A check in the amount of \$23,000 was presented to CAB as a result of the Poker Tournament sponsored in part by the Elks. Members of the cast were present to receive the check. A total of \$35,000 was raised to offset the \$38,000 cost of production.

Sheree McIntyre works with ACORN and voiced concern about an industrial port coming in to town. She also asked for a forum or workshop to discuss the port.

John Bellando stated he is the Co-Chair of the Heights Community ACORN Group and also voiced concerns about the port.

Frank Gordon stated regarding a port, that he has seen the plans, pro forma and satellite drawings showing the closure of Harbor and 3<sup>rd</sup> Streets. He asked for transparency and that the Council conduct a workshop.
